BASIC REQUIREMENTS (RSCI):

Scientific articles submitted for publication: should correspond to the Conference directions; reflect the results of the authors' personal researches; be relevant and scientifically innovative. **Text originality should not be less than 75%. Percentage of self-citation in the section «References» no more than 30%.**

An expert opinion must be provided for each article.

Maximum articles for one author – 3. Maximum number of authors per article – 5.

Articles should have the following main sections:

- 1. problem statement in general form and in connection with important scientific and practical tasks;
- 2. analysis of the latest achievements and publications where the problem solution has been started, highlighting the previously unsolved parts of the general problem;
- 3. formulation of goals and setting work tasks;
- 4. presentation of the main research material with full justification of scientific results obtained, formulation of recommendations;
- 5. conclusions on current study and prospects for further development of the direction. Article volume: no more than 5 pages. Text format: MS Word (file extension *.doc,
- *.docx). Page format: A4 (210×297 mm). Margins: 20 mm upper, lower, left, right. Font: size 10; type Tahoma. Formulas should be designed in editors MS Word Microsoft Equation Editor or Mathtype Equation Editor. Figures and tables are allowed in the text, no more than 3. Figures should be at least 60×60 mm and no more 110×170 mm in format *.jpg, *.bmp. Electronic version should consist an article in a separate file. File name should include the name of the corresponding author and the article title.

Article design:

- 1. UDC is indicated without indentation (left alignment), on the next line without paragraph indentation—CSCSTI (left alignment, line spacing 12 pt).
- 2. On the next line, without indentation, the title of the article is printed in capital letters, without hyphenation (font semi-bold, center alignment, line spacing 12 pt).
- 3. The surname and initials of the author(s) are printed on the next line without indentation, separated by comma (font semi-bold, center alignment, line spacing 12 pt).
- 4. On the next line, without paragraph indentation, the name of the organization, city, country is printed, separated by commas (center alignment, line spacing 12 pt).
- 5. On the next line, paragraph indented of 1,25 cm abstract is printed (justified alignment, the word «Abstract» font semi-bold).
- 6. On the next line, paragraph indented of 1,25 cm keywords are printed (justified alignment, phras «Keywords» font semi-bold, line spacing 12 pt). Further, paragraphs 2 to 6 are duplicated in English. The main text of the article is printed with paragraph indention of 1,25 cm and single line spacing. Examples of the design of figures, tables, formulas are presented in the design example of the article. Reference list design in accordance with GOST R 7.05- 2008.

The article should provide the following information: **UDC** codes; thematic rubricator sections (**CSCSTI**); article titles in Russian and English; names of the authors in Russian and English; lists of affiliations in Russian and English; abstracts in Russian and English (each at least 40 words); keywords in Russian and English (each block of 6-8 words); references; funding sources; **author's contacts**: surnames, names, patronymics (if applicable) in full, phone numbers (personal mobile), email addresses, names of organizations (completely according to the Charter of organizations), positions (without abbreviations), **SPIN-codes** of the authors registered at Science Index (for registration of the collection in RSCI), **ORCID ID** – for authors with publications in foreign scientific citation databases.
